The Finance Department Government of Khyber Pakhtunkhwa has received financing from the World Bank toward the cost of the Khyber Pakhtunkhwa Revenue Mobilization & Public Resource Management Program and intends to apply part of the proceeds toward payments under the contract for Services for Enterprise Data Warehousing, Big Data Analytics and Business Intelligence.

The Khyber Pakhtunkhwa Revenue Mobilization & Public Resource Management Program now invites sealed Bids from eligible Bidders for Services for Enterprise Data Warehousing, Big Data Analytics and Business Intelligence.

Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" Procurement in Investment Project Financing Goods, Works, Non-Consulting and Consulting Services July 2016 Revised November 2017 and August 2018 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
