The Finance Department Government of Khyber Pakhtunkhwa has received financing from the World Bank towards the cost of the Khyber Pakhtunkhwa Revenue Mobilization & Public Resource Management Program and intends to apply part of the proceeds toward payments under the contract for Procurement of Hardware & Software for Workflow and Document Management Systems. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" Procurement in Investment Project Financing Goods, Works, Non-Consulting & Consulting Services July 2016, Revised November 2017 and August 2018 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations. Bidders may bid for one or all lots. Evaluation and award shall be on basis of lots.
